Overall Considerations:

- Be careful in your consideration of data. Be sure to look closely for what data you need to fulfill your research question(s) and ask only for information that is needed.
- Make sure to include the requests for each institution type you need (campus type in Key above); also be careful to include the years AND quarters for each data set. If need all quarters, can list just the year; we will assume if you don't list any quarters, you want/need all of them for that year.
- · Data variables differ slightly by year and also by institution type. Make sure to look closely at each data set as you work.
- Students may be enrolled in several institutions of the same type (and of differing types) during the same term. Keep this in mind as you work and restructure the data for your needs.
